



- ix) That there shall be reservation of seats for SC/ST/OBC other categories etc. as per the policy of State Govt.
- x) That the supporting and other staff will be appointed as per the guidelines of the State Govt./ the affiliating University.

xi) That the institution shall charge only such fee as prescribed by the affiliating body/ State Covt. concerned in accordance with provision of NCTE (guidelines for Regulations of tuition and other fees chargeable by unaided teacher education institutions) Regulations, rees 2002 as amended from time to time and shall not charge donations, capitation fee etc. S Nag 1 No 10337 om the students. > xii) That the academic and other staff of the institution (including part time staff) shall be paid such salary as may be prescribed by the concerned State Govt./University form time to time through bank.
